Unto His Grace The Duke of Argyll

The Petition of Alexander McLean Duncan Campbell John Macdonald John Brown John Macphaill Alex' Campbell John Campbell John Bell Neil Campbell Hector Campbell and John McFarlane all tenants in Ballinoe in the Island of Tyree

#### Most Humbly Sheweth

That your Petitioners in consequence of a Tack from you Grace possess the said Lands their Entry to which commenced Whitsunday 1785 and to continue for Nineteen years thereafter and consequently terminating at Whitsunday next, during which time the Rent of that farm has been regularly paid, as their receits [sic] which are ready to be produced, if required will shew. That your Petitioners till of late enjoyed their possessions comfortably. But now (tho near the close of their Tack) finding themselves much harassed and oppressed in their possessions they are under the necessity of supplicating your Grace and informing you of their reasons. In the first place they have been prevented from cutting their Peats this Season and only upon Saturday last was allotted a piece of Moss no way sufficient for fuel or to which they had right and possessed hitherto do that they

do not know how, (that the season is so far advanced) to be supplied for the remainder of the year, in that article. In the next place they are oppressed by the Factor & Surveyore [sic] taking advantage, not only of the Petitioners, but of others of your Grace's Tenants by their traffic and purchasing of

The petit<sup>rs</sup> also consider it a hardship (tho by their Tack they are bound to give so many days service), to be under the necessity of not only serving the Factors own particular occasion, but also his servants, in place of doing <sup>it</sup> for the Good of the Country – and the end of the Island in which the Petitioners reside has, by the Factors doing been disappointed of a Miller to grind their grain and your Grace's tenants necessitated to beg or borrow meal from each other, and often to take an uncommon method of grinding such grain as they have altho' known to be plentiful – the Petitioners do not complain of your Grace's Lands and not withstanding of their being for six years back obliged to pay

an additional sum for Stipend on Teind either in kind or money, are still willing to give Ten pounds Stirling yearly of an augmentation upon their getting a renewal of their Lease, providing they get proper usage or Factorship and they trust that they will at least be preferred upon equal terms
