Donald M^oMillan, Cottar, Moss Says

57 years My house is about 150 yards from that in which Sarah $M^\circ D$ onald lived. — I was in the habit of going daily to see her. — She was my sister in law. — I think she was considerably above 70 years of age. She was not very strong but till about a fortnight before her death she was able to go about among the neighbouring farmers & do some light work. She got her food from the people for whom she worked and it was in this way chiefly that she lived. — She had only 1/6 a month from the Parochial Board. —

For about 10 or 14 days before her ~

her death she was confined to the house and in fact was but rarely out of bed. She complained of headache and general weakness. - I at first did not think her illness serious and I neither informed the Inspector of Poor nor sent for the D^r. - My wife went several times a day to see her and make her food, and the other neighbours often called to see her. - A day or two before her death I saw that her illness was more serious than I at first thought. - I did not even then send for the D^r. as I had heard that Alex^r Carmichael, a neighbour, had told the Inspector of Poor of her illness & I thought that ~~

that the Inspector would inform the D^r. - The D^r however did not come. - On Friday 25th February 1870 deceased was very ill and I told her my wife would stay with her and attend to her. - She replied that it was not necessary and that she would rather that no person should stay in her house. – I did not insist but I, my wife and the neighbours called oftener than usual that night. - I left her house about 7 o'clock that evening. – Next morning

about 9 o'clock I called to know how she was. - When I opened the door I asked if she was better but I got no answer. - I then went in~

in & going up to her bedside again asked if she was better. I still got no answer. - I took hold of her hand and feeling it very cold it struck me she was dead. - I satisfied myself of this & then went home & told my wife. - She returned with me and several other women came in shortly after. - I left them to dress the body. - The remains were interred in the churchyard of Soroba in the parish of Tyree on Monday 28th February 1870. –

Her death I believe resulted from natural causes. – I was at the funeral. –

The deceased Sarah McDonald was my sister. - She was about 77 years of age. - She was a pauper and lived in a house alone. - Her house is about 150 yards from ours. - I corroborate & concur with the evidence of my husband as to the general health of deceased and also as to her last illness. - During her illness I called at least three times a day, and prepared her food which consisted only of a cup of tea & some bread & butter. - I did so on Friday 25th February 1870 as usual. The last food I gave her was some ~

some tea & bread & butter about 3 P.M. on Friday. – She was then very ill & I offered to remain in the house with her that night but she would not allow me. - I however stayed till about 8 P.M. I left her alone. - About 10 A.M. next morning

my husband came in to the house & told me my sister was dead. - I went to her house & dressed the corpse with the assistance of several women who came in after me. –

From her age & the state of her health for some weeks before her death I believe she died from natural causes. There was plenty of food in ~

I am Inspector of Poor for the Parish of Tyree. - The deceased Sarah M°Donald was a pauper. - She was 73 years of age and in ordinary good health. - Her allowance from the Parochial Board was 1/6 per month, but she was able otherwise to earn a good deal more than this. - She had a house at Moss, from the Board, in which she lived alone. - Her sister lives about 150 yards from her & there are several other families in the immediate neighbourhood. - Deceased was often from home. I saw her last on 24th January 1870. She was then in her usual health. - I heard of her ~

often from that time up till her death, and on every occasion except the last she was said to be in good health.

On Thursday 24th February last a neighbour of hers, named Carmichael, had occasion to come to my house. - In the course of conversation he mentioned to me that Sarah McDonald was unwell. - He did not seem to think her illness was serious. - I expected however to be in her neighbourhood next day and intended to see her but the weather became so boisterous that I was prevented. - Early on Saturday morning

I (knocked) thought she was from home.

I did not hear of deceaseds death for about a week after. - I did not see the body. - I did not hear she was ill and no one asked me to visit her. -
