Report by Procurator Fiscal at Tobermory as to the death of Mathew Byrne Mate, Robert Mackay, Thomas Wedick, James Donley or Donelly, James Kehoe, - all seamen and residing in Arklow, and Herman Hallander, a Cook and native of Gottenburg, Sweden

The deceased were all serving on board the Brigantine "Nancy" of Dublin of the burthen of 300 tons and of which Richard Kerrow of Arklow was Master -

This shop sailed from Liverpool on Friday 6<sup>th</sup> February 1885 laden with a cargo of Salt bound for New Castle upon Tyne. They rounded Skerryvore Lighthouse at 2 A M of Sunday the

the 8th February 1885 -

About 5 A M of the same morning the weather being thick and stormy the vessel struck on the Dubhsker an outlying rock about three miles to the North West of Craignish Point on the island of Tiree - The Captain and three of the Crew were on the deck at the time, the other three being below in their berths - The vessel immediately after striking split in two and Sank, The Captain who was standing on the Poop was floated away on it, and he says that he saw none of the crew as they went down with the Ship - The Captain drifted landwards, and after being on

the piece of Wreck for ten hours was landed on a small outlying Island a short distance from Craignish Point, on the afternoon of Sunday he was seen by some men from the shore of Tiree and they tried to launch a boat to go to his assistance but the surf on the beach was so great and the wind so strong on the lee shore that they were unable to do so, The island on which the man was standing was within 100 yards of the shore, and when the men found themselves unable to reach him they tried to pass a rope to him but failed in this also, and darkness coming on they had to leave, - They returned next

next morning about six o'clock and the weather then having somewhat moderated and the tide being low they waded into the sea and got within forty yards of the rock and by attaching a stone to the end of a rope they succeeded in throwing it to him and after attaching it round his waist they pulled him thro' the surf to the shore and so rescued him, He was on the rock all night and was much exhausted after an exposure of upwards of 24 hours, He gave the name of Richard Kerrow and informed them that he was master of the

the "Nancy" which had struck the previous morning on a rock about three miles from land and that the crew with the exception of himself had all been drowned, that the vessel split into two and sunk almost

immediately after striking and that he was floated away on the Poop on which he was standing at the time the vessel struck -

None of the bodies have come ashore -

The above facts were ascertained on the spot by an Examination of the following Witnesses
